- Workgroup meetings - Habitability, Lead Poisoning Prevention, and Indoor Air Quality Workgroups breakout sessions.

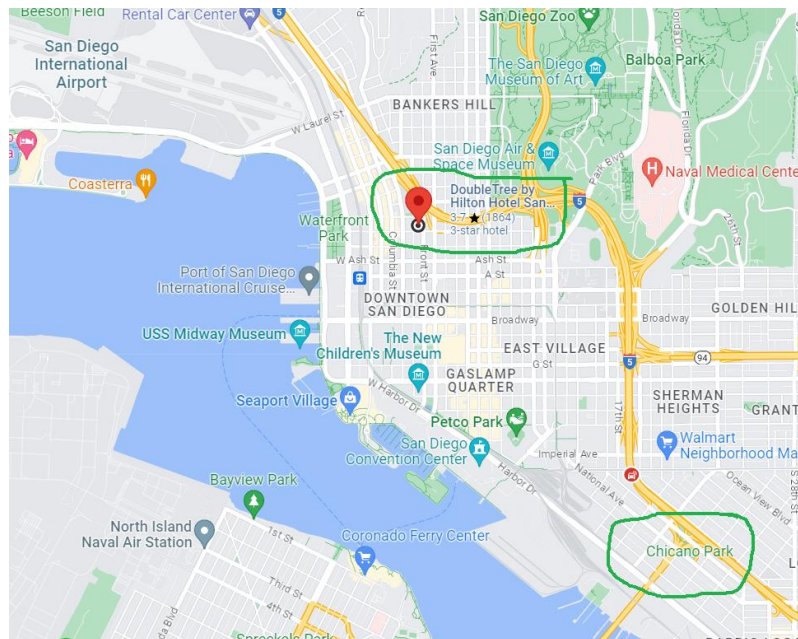
Day Two:
