

Congress Cuts HUD's Lead Hazard Reduction Grants by 31%

What Happened?

Congress cut HUD's FY24 appropriations for its Lead Hazard Reduction Grant Program by 31%, from \$290 to \$200 million for FY24. HUD requested \$265 million for the program—an 8.6% cut, significantly less than what Congress decided upon. For context, HUD's overall FY24 funding was cut by 1.9%.¹

Making matters worse, Congress also took back \$65 million appropriated in FY22 for this program that HUD had until September 30, 2024, to obligate by issuing grants to communities to clean up leadbased paint hazards.

In addition, HUD already planned to close its Lead Risk Assessment Demonstration Grants Program because it received no eligible proposals.²





The Biden Administration released its proposed budget for FY25. <u>HUD's budget</u> requests \$350 million for its Office of Lead Hazard Control and Healthy Homes, only \$5 million more than <u>Congress approved</u> last week for the Office in FY24.¹ The highlights for Office are:


- Setting aside 80% of the \$200 million for Lead Hazard Reduction Grants based on a formula rather than a competitive approach. This is the first time HUD has proposed a formula approach, saying it will "allow more efficient distribution of funding to the highest need communities, streamline the selection and award of grants for communities facing large lead paint problems." The balance will be competitive and "open to a broader range of States, Native American Tribes, and communities with pre-1978 rental housing."
- Setting aside \$46 million of the \$130 million request for Healthy Homes Grants and Support based on a formula approach. HUD will award them proportionally to those receiving Lead Hazard Reduction Grants to address other housing-related health and safety hazards in homes being treated for lead hazards, based on formula described in previous item. This will ensure that grantees—both those with formula grants and those with competitively awarded lead hazard reduction grants—will continue to be able to address those other health hazards.


resulted in a \$305 million settlement; \$24 million was allocated to the City of Oakland and Alameda County, which share jurisdiction.

On December 21, the Oakland City Council authorized a Memorandum of Understanding, which was also authorized by the Alameda County Board of Supervisors on December 16, 2021, allocating **60% (\$14 million) of the settlement funds to the City of Oakland** to fund lead poisoning prevention services within the City and 40% of the funds (\$9.6 million) to fund lead poisoning prevention services within Alameda County but outside of Oakland. The City will receive 20% (\$4.8 million) now to fund development of an Equity-Based Lead Program to implement the recommendations outlined in the Equity Impact Analysis.

Oakland's Equity-Based Approach will be Proactive, Targeted

- 20% to City of Oakland for development of a plan and initial activities
- 40% to County for lead poisoning prevention activities outside of Oakland
- 40% to be negotiated between City and County.

Lead Settlement Funds Allocation



- Initial City Disbursement 4.79 M
- Oakland Services-TBD 9.59 M
- County Services Allocation (outside Oakland) 9.59 M

2019 – Court Settlement ordered County and City negotiate

- 2020 County and City meet
- 2021 County and City reach agreement allocation
- 2022, 23, 24 City does not produce plan

Option: County goes back to court as these funds remain in HHD budget and can't collect interest but can't be spent either.

• In November 2024, Bay Area residents may vote on a regional bond measure to generate up to \$20 billion to build more affordable homes and help keep existing homes affordable. A \$20 billion dollar bond could create 72,000 new affordable homes — more than double what would be possible without a bond.
